Для сведения собственников: следующий пересмотр уровня кадастровых цен на землю в сторону увеличения запланирована Министерством имущественных отношений со следующего года, при этом разработчик будет брать за основу достигнутый утвержденный уровень. Поэтому мой совет - лучше уже сейчас добиться уменьшения уровня стоимости, с тем, чтобы следующее увеличение цен не было бы необоснованно резким.
